Course Title: The Agricultural Industry

Credit: 1 Lecture: 1 Lab: 0

Course Description: Overview of agriculture and the American agricultural system, including an examination of career opportunities and requirements.

Semester Hours: 3 Lecture Hours: 3 Lab Hours: 1

Emphasis is placed on introducing the student to the agricultural systems in Hockley County and the surrounding area. Area farms and ranches will be visited throughout the semester interviewing owners, managers, and employees to consider each career available.

Prerequisites: None

Textbook: Textbook is not required. Instructor will provide free resources.

CORE OBJECTIVES TO BE ADDRESSED:

Communication – to include effective written, oral, and visual communication.

Critical Thinking Skills – to include creative thinking, innovation, inquiry, and analysis, evaluation, and synthesis of information.

Empirical and Quantitative Skills – to include the manipulation and analysis of numerical data or observable facts resulting in informed conclusions.

Teamwork Skills – to include the ability to consider different points of view and to work effectively with others to support a shared purpose or goal.

Course Purpose/Rational/Goal: The objectives of this course are to provide an overview of careers and opportunities in the agriculture industry. Students will be able to research and learn various agricultural systems and opportunities available in the Agriculture and Animal Science industries.

Course Requirements: The course will meet a minimum of twice a week.

Course Evaluation: Grades will be obtained via weekly assignments, major exams, and projects. Percent of total points will be calculated by the normal scale.

Attendance Policy: Even though this is an online or hybrid class, students still must access the course on a regular basis. The Blackboard software used to manage this course tracts student logins, tracking when and where the student has been in the course. Accessing this course on a regular basis is extremely important to meet the objectives of this course.

Students are expected to attend all classes to be successful in a course. The student may be administratively withdrawn from the course when absences become excessive as defined in the course syllabus. After 4 unexcused absences, students will be warned of excessive absences. **After 6 unexcused absences**, students will be dropped from the course with an "X".

When an unavoidable reason for class absence arises, such as illness, an official trip authorized by the college or an official activity, the instructor may permit the student to make up work missed. It is the student's responsibility to complete work missed within a reasonable period as determined by the instructor. Students are officially enrolled in all courses for which they pay tuition and fees at the time of registration. Should a student, for any reason, delay reporting to a class after official enrollment, absences will be attributed to the student from the first-class meeting.

Students who enroll in a course but have "Never Attended" by the official census date, as reported by the faculty member, will be administratively dropped by the Office of Admissions and Records. A student who does not meet the attendance requirements of a class as stated in the course syllabus and does not officially withdraw from that course by the official census date of the semester, may be administratively withdrawn from that course and receive a grade of "X" or "F" as determined by the instructor. Instructors are responsible for clearly stating their administrative drop policy in the course syllabus, and it is the student's responsibility to be aware of that policy.

It is the student's responsibility to verify administrative drops for excessive absences through MySPC using his or her student online account. If it is determined that a student is awarded financial aid for a class or classes in which the student never attended or participated, the financial aid award will be adjusted in accordance with the classes in which the student did attend/participate, and the student will owe any balance resulting from the adjustment.

- 3. Assess careers in agriculture and related educational requirements.
